Please find the following questions and clarifications with regards to the above bid opportunity.

Question 1: In regards to note 3 on drawing E100 (Fire Curtain: Provide separate Life Safety Circuit ,120volt, 20amp circuit, from nearest available source). Where is the nearest available source?

Answer: Field exploration and determination to be completed to determine nearest available source.

Question 2: What is the parking situation for the contractor?

Answer: There is free parking along 5101 John C. Lodge, alongside the Matthaei Athletic Facility. There is covered parking across the Lodge at Parking Structure 2 at 5150 Lodge Service Drive; however, there is an \$8.50 fee per access. You may also visit the Welcome Center at 42 W Warren Avenue where you can acquire a Guest Card. You may load monies onto the card and use it in Structure 2 or any other Parking Structure on campus.

Question 3: Can I receive a list of the bidders?
