**Addendum Three To
Request for Proposal
For Computing Service Center Breakroom and Hallway Improvements 2015: Project 193-258618**

Questions were submitted as a result of the Pre-proposal Meeting September 14, 2015 and the walk-thru of the project site. The questions and the University's responses are as follows:

Question 1: Flooring in breakroom 128. Sheet F1.1 Finish floor plan and Legend indicates "SV-1 (*RB-1)" for the flooring in the breakroom. The "Finish Key" on this same page does not provide a description for "SV-1(RB-1)". The "Finish Key" does list "LVT-1" for vinyl plank. Please confirm if this room is to receive "LVT-1".

Response: Please see Addendum 3 09.22.15 Sheet F1.1 for clarification.

Question 2: Window framing and sill details for breakroom 128. Sheet A1.1, note 1, indicates new "butt glazed glass on 3'-6" knee wall." The elevation on sheet A6.1 implies a perimeter frame. The existing masonry wall scheduled to remain and the new partition (Type 1B) above) will have dissimilar thicknesses. Please provide head, sill, and jamb details for the window openings in room 128.

Response: Please see Addendum 3 09.22.15 Sheet A1.1, A2.1 and A6.1 for clarification.

Question 3: Electrical outlets for new vending machine locations in room 122. Sheet E2.1, note 1 indicates electrical outlets for the new vending machines located on the existing stairwell wall. Is it the intent that these new outlets be installed with surface mounted conduits and boxes to avoid accessing the existing fire rated stair way wall?

Response: Please provide surface mounted electrical boxes and conduit to new vending machines.

The Addendum must be acknowledged on your lump sum bid.
