# RFP State Hall Renovation dated January 17, 2023

## This Addendum must be acknowledged on Schedule D

Questions have been raised during the Pre-Proposal meeting held on **January 24, 2023** for the University's RFP for **State Hall Renovation** for the **Design & Construction Services.** A summary of the questions asked and the University's responses are as follows:

#### Question:

T-16 is listed on Cost Schedule C, but we do not have specifications for T-16 in the furniture package. Please confirm what/if these specs are and if we need to provide pricing for this item.

#### Answer:

See attached specification sheet

### Question:

Bid Documents states readiness for service is week of July 24, 2023 and project completion is August 18, 2023. Comments during the pre-proposal meeting were that school starts August 1<sup>st</sup>. please confirm installation window. Concerns with the amount of product and potentially multiple dealers and/or vendors trying to use one passenger elevator in a short amount of time.

#### Answer:

School starts the middle to the third week in August. The stated timeline should be sufficient for installation.

#### Question:

Please confirm if 53' tractor trailer can park on Cass Street for deliveries.

## Answer:

Yes, a 53' tractor trailer can park on Cass Street for deliveries. Coordination with the project manager will be required as the University may require the assistance of Public Safety.

#### Question:

Confirm labor rates required for furniture installers. Prevailing wage and Union installation are referenced in bid documents. We reviewed WSU wage rates page and are still unclear what rate is needed.

#### Question:

In reference to Ticket T-01A, are you accepting non-height adjustable tables for alternates?

#### Answer:

No, the design intent with the variety of table heights is to accommodate for a variety of users and provide more accessibility. We are only accepting alternates that are height adjustable.

### Question:

In reference to Ticket T-04 and T-05, will you accept other shapes for the table tops as alternates?

#### Answer:

Yes, other organically shaped table tops will be acceptable. The design intent is to promote more collaborative work between students.
